Fees for Clinical and Forensic Services

My fees are consistent with governmental guidelines suggested by the Health Care Financing Administration (HCFA), reimbursement schedules of most insurance companies, and with those charged by other local psychologists. My contract with individual insurance companies may require me work within their fee structure. While my fees remain constant, final charges to my patients may be adjusted to account for insurance rates of reimbursements, required write offs, etc.

<ul style="list-style-type: none"> • Initial Diagnostic Interview • CPT code 90791 	The initial 50-60 minute visit, including setting up an account, filling out insurance papers and treatment plans, and any initial testing.	\$190.00
<ul style="list-style-type: none"> • Individual Psychotherapy • CPT code 90832 	25-30 minutes with patient or family member.	\$120.00
<ul style="list-style-type: none"> • Individual Psychotherapy • CPT code 90834 	45-50 minute individual counseling session. This is the most common service charge.	\$160.00
<ul style="list-style-type: none"> • Individual Psychotherapy • CPT code 90837 	60 minute individual counseling session. This is billed if the session exceeds the usual 50 minutes.	\$180.00
<ul style="list-style-type: none"> • Conjoint/Family Psychotherapy • CPT codes 90846, 90847 	45 minute couple or family counseling session, with or without the patient present.	\$160.00
<ul style="list-style-type: none"> • Interactive Complexity Add-On • CPT codes 90785 	This code can be added if the visit is unusually complex (i.e., needing an interpreter, multiple people in the room, special equipment, etc.).	\$30.00
<ul style="list-style-type: none"> • Psychological/Neuropsychological Testing • CPT codes 96101, 96102, 96116, 96118, 96119 • Can be done either by psychologist or a trained technician. 	Interviewing, records review, administration, scoring, and interpreting psychological tests. Report writing is bundled in this fee on the date the final report is prepared.	\$160/hour
<ul style="list-style-type: none"> • Forensic Examinations • Diagnostic interviewing, testing, records review, scientific literature review research, and report preparation. • CPT code 90899 	Any service provided for legal purposes for use in a court setting.	\$190/hour
<ul style="list-style-type: none"> • Court testimony • CPT code 90899 	Expert testimony and/or deposition.	\$250/hour
<ul style="list-style-type: none"> • Travel Time • CPT code 90899 	Time traveling away from my office, such as making house calls, traveling to facilities, etc.	\$140/hour
